9. New Business

a. Bylaw 13-01 Bylaw to Provide for the Election of the Office of Mayor

There has been discussion about the bylaw to provide for the election of the Office of Mayor by separate ballot. Attached is a copy of Bylaw No. 13-01.

The Municipal Government Act, section 150 states that: The chief elected official of a village, summer village or municipal district is to be appointed by council from among the councillors unless the council passes a bylaw providing that the official is to be elected by a vote of the electors of the municipality.

The Municipal Government Act, section 151 states that: A bylaw under section 150 must be passed at least 180 days before the general election at which it is to take effect. If a bylaw is passed less than 180 days before the next general election, it takes effect at the 2nd general election after the date on which it is passed. A bylaw passed under section 150 must be advertised.

Municipal Affairs have confirmed that the same process must be followed should a bylaw for the election of the Office of Mayor be repealed.

MOVED by Councillor Power that the Council of the Village of Breton repeal Bylaw No. 13-01 a Bylaw to Provide for the Election of the Office of Mayor and revert back to Section 150 of the Municipal Government Act requiring council to appoint the chief elected official from among the councillors.

f. 39/20 Alliance Discussion Item – Community Peace Officer Services

At the October 28, 2015 Regular Meeting of the 39/20 Alliance members reviewed and discussed the option of having a shared agreement for Community Peace Officer services. It was agreed that Alliance members would share the report prepared by the Town of Calmar with their Councils and discuss the matter.

The Town of Calmar document outlines the present duties and costs of their Peace Officer and have forecasted what expanded duties to Thorsby, Warburg and Breton could look like.

The Village of Breton contracts Doris Mc Allister for 2 days per month at a rate of \$40.00 per hour to enforce municipal bylaws and act as the animal control officer.

It may be beneficial to hear from the RCMP and possibly the Calmar Peace Officer to become familiar with the merits of the proposal.

MOVED by Councillor Power that the Council of the Village of Breton accept the Community Peace Officer Services document as information.

g. Breton Seniors Request for Sidewalk Maintenance

On November 4, 2015 Pat Simpson, President of the Breton Seniors asked if the village could clear and deice the sidewalk at the Golden Age Centre when needed this winter. They are willing to pay for the work.

Administration understands that the location and area of sidewalk to be maintained is not an issue however there remains the concern of adding additional duties to the public works department that regularly occurs overtime to complete snow removal. There are other local businesses and/or individuals who have equipment and offer snow clearing services.

The current snow removal and sanding policy does provide for the removal of snow piles from private lots provided that the owner shall pay the associated costs of manpower and equipment, that the request be in writing and is dependent on the workload of the public works department.

In addition the Public Works Department informed Administration that the Village does remove the snow and deice the sidewalk in front of the Golden Age Centre.

MOVED by Councillor Doucette that the Council of the Village of Breton direct Administration to clarify where the Seniors wish to have the snow removed from the property. CARRIED

i. Offer to Purchase 15 Fraser Drive, Fred Barke in Trust for Marilyn Barke

The Village received an offer to purchase Lot 9, Block 23, Plan 122 3297, 15 Fraser Drive from Fred Barke in Trust for Marilyn Barke in the amount of \$42,000.00 including GST and less commission and includes the installation of a culvert.

The list price for this lot and the remaining four lots is \$49,500.00 including GST and less commission.

MOVED by Councillor Power that the Council of the Village of Breton submit a counter offer for the sale of Lot 9, Block 23, Plan 122 3297, 15 Fraser Drive in the amount of \$47,000.00 including GST.

j. Development Permit Application No. 222 to Place a New Mobile Home at 132 Willow Drive Joanne Nelson has made application to place a new mobile home at 132 Willow Drive. The property is zoned R1B, a mobile home is a discretionary use of the R1B zone.

The plan is to place the mobile home on the short side of the lot. The short side is 113.52 feet. The mobile home is 16' feet wide and 76' feet long. The regulations state that minimum front yard setback shall be no less than 23 feet. As a result the rear yard setback will be 14.5 feet and the regulations states that a rear yard of not less than 26.2 feet shall be provided.

On December 11, 2013 Council approved Development Permit No. 182 for 132 Willow Drive that provided for a rear yard relaxation to accommodate the placement of a new mobile home from 26.2 feet to 14.5 feet.

Council has the option of granting the rear yard relaxation, varying the rear yard relaxation or denying a rear yard relaxation.

MOVED by Councillor Power that the Council of the Village of Breton approves the granting of the rear yard relaxation for Development Permit Application No. 222. CARRIED

k. Draft Regional Agreement Municipal Preparedness (RAMP) and Draft Regional Agreement Municipal Preparedness Plan

On November 6, 2015 administration met with Merlin Klassen, Brazeau County, Denis Poulin, Drayton Valley and Rick and Shirley Ennis, Ennis & Associates Ltd. to review and comment on the proposed RAMP Agreement and RAMP Plan between the Village of Breton, Brazeau County and Drayton Valley.

Comments from all parties with proposed changes are highlighted.

It was agreed to take the proposed agreement and plan to our respective council for comments and questions.

MOVED by Councillor Doucette that the Council of the Village of Breton agrees in principle with the draft Regional Agreement Municipal Preparedness (RAMP) and the draft Regional Agreement Municipal Preparedness Plan, however budget and sharing of costs requires further discussion prior to entering into the agreement.
